










Where can I ride in Toronto?

Text-only version of “Where can I ride in Toronto?”

Below is a summary of where different micromobility, also known as rideables, can be legally ridden in the City of Toronto. The listings below do not include assistive mobility devices, which can legally be ridden on trails and sidewalks.

Each different vehicle type is listed by heading.

Bicycles, tricycles and electric powered bicycles/tricycles that require some muscular power

Can be ridden on roads, painted bikeways, physically separated bikeways, and trails. On trails, e-bikes must weigh less than 40kg.

Can not be ridden on sidewalks, except by children 13 years old or under.

Cargo, electric cargo bike or tricycle that requires some muscular power

Cargo means it has a cargo container in the back or front.

Can be ridden on roads, painted bikeways, and physically separated bikeways.

Can not be ridden on trails or sidewalks.

Throttle electric motorscooter that requires no pedalling and no muscular power.

Limited to maximum of 32 kilometers per hour speed capability.

Can be ridden on roads and painted bikeways.

Can not be ridden on physically separated bikeways, trails or sidewalks.

Electric scooters

These include electric kick-scooters, skateboards, kick-scooters with a seat, unicycles, one-wheels and hoverboards.

Not defined to be allowed under the Ontario Highways Traffic Act, except for electric kick-scooter. Electric kick-scooters are allowed through a provincial pilot project which some cities have participated in. City of Toronto did not participate in this pilot and electric kick-scooters are not allowed to be ridden on sidewalks, bikeways, trails or any other public property.

Other muscular powered devices

These include skateboards, in-line skates (roller blades), and kick-scooters.

Can be ridden on trails and sidewalks, except where posted to prohibit. Must not ride recklessly or negligently.

Motorcycles and mopeds (motor scooters)

Capable of speeds greater than 32 kilometers per hour.

Can only be ridden on roads, requires a license plate, be insured, and registered through Service Ontario.

Can not be ridden on bikeways, trails or sidewalks.

Low-speed vehicle (e mini-car)

Must meet federal standards, have licence plate, be insured and registered through Service Ontario. Max 40 kilometers per hour speed capability. Requires driver's licence to operate. Only on roads with maximum speed limit of 50 kilometers per hour.

Electric enclosed three-wheeler or electric enclosed 4-wheeler not meeting Low-Speed Vehicle standards

Not allowed under Ontario Highways Traffic Act.
